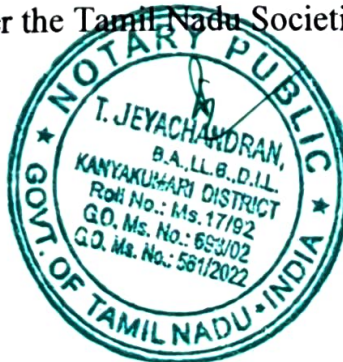

NOW THIS DEED WITNESSETH AS FOLLOWS

1. Donation of Vehicle

The Donor Association hereby donated the van on demand by Correspondent, Scott Christian Higher Secondary School and transfers possession of one School Van bearing the following particulars:

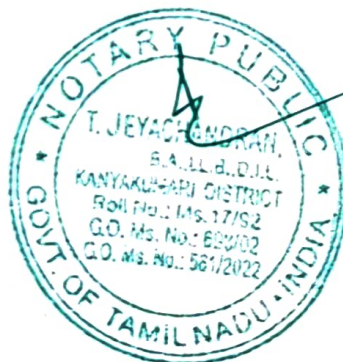

2. Registration

The Donee School shall register the said vehicle in the name of the School in accordance with the provisions of the Motor Vehicles Act and applicable rules in force in Tamil Nadu.

3. Donor Identification

The Donee School agrees that the following inscription shall be permanently displayed on the vehicle in a visible manner:

“Donated by Scott Christian Higher Secondary School Alumni Association”

The Donee School shall also make reasonable efforts to mention such donor details, wherever permissible, in the records submitted before the Regional Transport Office (RTO).

4. Purpose and Usage Restriction

The Donee School undertakes that the vehicle shall be used solely for the transportation and welfare of students and staff of the School in connection with educational, cultural, sports, and official institutional activities.

The vehicle shall not be used for any:

Personal purpose

Private use

Political activity

Commercial activity

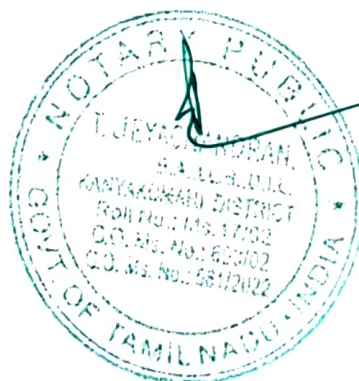
Rental or hire service

without the prior written consent of the Donor Association.

5. Restriction on Transfer or Encumbrance

The Donee School shall not sell, transfer, mortgage, lease, pledge, hypothecate, or otherwise create any encumbrance over the vehicle without obtaining prior written approval from the Donor Association.

6. Maintenance and Operational Responsibility



All expenses relating to fuel, driver salary, maintenance, repairs, insurance, taxes, permit charges, and statutory compliances shall be borne by the Donee School from the date of handing over the vehicle.

7. Violation of Conditions

In the event of substantial violation of the terms and conditions contained in this Deed, the Donor Association shall have the right to issue a written notice seeking rectification within a reasonable period.

If the violation continues despite such notice, the Donor Association shall be entitled to seek appropriate legal remedies before the competent court of law.

8. Binding Nature

This Deed shall be binding upon both parties, their successors, administrators, and representatives.

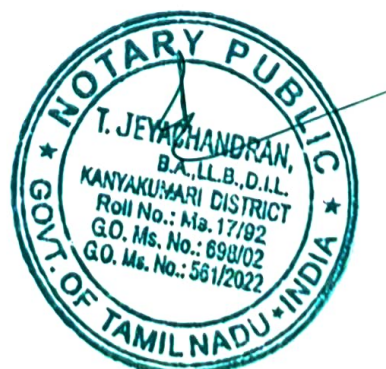

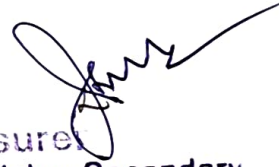
