MEMORANDUM OF UNDERSTANDING- (MoU) II

Between

Scott Christian Higher Secondary School

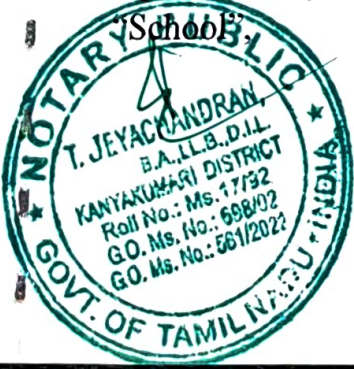
and

Alumni Association

This Memorandum of Understanding (MoU) is made on this 14 day of May 2026 at Nagercoil, Tamil Nadu, between:

1. Scott Christian Higher Secondary School

represented by its Headmaster and Correspondent, hereinafter referred to as the



AND

2. The Alumni Association represented by its President, Secretary, and Treasurer, hereinafter referred to as the "Association".

PURPOSE

Whereas, it is proposed to purchase a School Van for the use of Scott Christian Higher Secondary School for the benefit of students and school-related activities;

And whereas, the total estimated cost of the said vehicle is approximately Rs.22,10,000/- (Rupees Twenty Two Lakhs Ten Thousand only);

And whereas, the Association has agreed to contribute an initial amount of Rs.10,10,000/- (Rupees Ten Lakhs Ten Thousand only) towards the purchase of the vehicle;

And whereas, since the loan is proposed to be availed in the name of the Association, the Association has agreed to avail a loan of approximately Rs.12,00,000/- (Rupees Twelve Lakhs only) from a Bank or Private Finance Institution for meeting the balance cost of the vehicle; (Advance paid by association Rs.50,000/- Fifty Thousand Only vide Cheque No: 034266 dt-12.5.26)

And whereas, due to the increasing student strength and urgent necessity of transportation facilities, both parties considered the proposal necessary and beneficial to the School;

Now therefore, both parties mutually agree to the following terms and conditions:

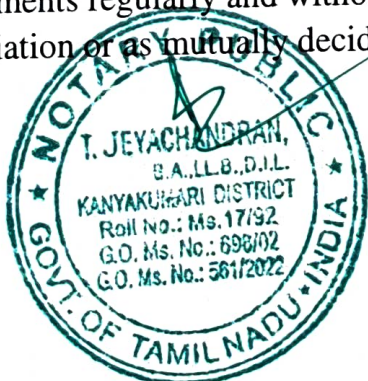
TERMS AND CONDITIONS

The Association shall provide an initial contribution of Rs.10 lakh towards the purchase of the School Van.

The balance amount required for the purchase of the vehicle shall be raised through a loan availed by the Association from a Nationalised Bank or Private Finance Institution.

This matter was discussed in detail in the Board Meeting of the Association as well as with the School Management, and both parties have mutually consented to proceed with the proposal.

The School Management hereby agrees and undertakes to pay the monthly EMI installments regularly and without default to the concerned lending institution through the Association or as mutually decided.



In the event of any default, liability, or legal issue arising out of the repayment of the loan, the School Authority shall be held responsible.

It is mutually agreed by both parties that the School Van shall be utilised solely and exclusively for the purposes of Scott Christian Higher Secondary School.

The vehicle shall not be diverted or used for any personal, commercial, or unrelated purposes without the written consent of the Association.

In case of any dispute, misunderstanding, or deficiency arising out of this Agreement, both parties agree to resolve the matter amicably through mutual discussion and, if necessary, by referring the matter to an Arbitrator acceptable to both parties.

This MoU shall come into effect from the date of signing by both parties.
